



# Visa options for amateur sports persons, support staff, spectators and related media personnel

## Overview

This fact sheet is a general guide to the most common visa options for those travelling to Australia as an amateur sports person or team (including support staff, spectators and related media personnel) to participate in amateur sporting events.

The information contained in this fact sheet is current as at **1 July 2017**. Australian migration law may change after this time resulting in a change in visa options.
