## COVID-19

Only persons who do not report any symptoms of health problems (increased temperature, muscle pain, cough, etc.) and at the same time have not been in contact with the covid-19 positive person in the previous two weeks, can take part in the race.

All participants in the race (organizers, judges, competitors, other club members and other officials) are obliged to comply with the currently valid rules, measures or regulations issued primarily by the Government of The Czech Republic, the Ministry of Health of the Czech Republic or other institutions in connection with the dissemination of Covid-19.

All competitors and judges must submit a signed [attached](#) "Affidavit" during their presence that meet the conditions for admission to mass events.

The organizer will check the certificate of infectivity of each competitor.

# AFFIDAVIT - COVID-19

**I make oath and say/affirm that:**

- I have a negative PCR test not exceeding 7 days old,
- or I have a negative POC (so-called antigenic) test not exceeding 72 hours old
- or I have a laboratory confirmation of having recovered from covid-19 disease in the period not longer than 180 days before the day of the event.
- or I have at least 14 days after the second dose of a two-dose vaccine.
- In the case of a single-dose vaccine, at least 14 days must have passed since vaccination.
