2. GENERAL RULES GOVERNING CANDIDATURES

By signing this form, the undersigned acknowledges and accepts that:

1. candidates who have already submitted a candidature for a different position within the General Board shall be ineligible to submit another candidature.
2. members of the Athletes' Commission are elected in a personal capacity and shall act independently, and not as representatives of any Member Federation.

3. DECLARATION OF ELIGIBILITY

I, the undersigned, hereby formally declare under my personal responsibility that:

A. General Eligibility Requirements

- I have not been convicted by a final and binding criminal judgment for intentional (non-negligent) offences resulting in custodial sentences exceeding one (1) year, nor have I been sentenced to penalties involving disqualification from holding public office for a period exceeding one (1) year.
- Within the last ten (10) years (save in cases of rehabilitation), I have not been subject to final sporting sanctions or bans imposed by United Rafting with an aggregate duration exceeding one (1) year.

B. Anti-Doping integrity

- I have not been sanctioned with a suspension exceeding one (1) year for an intentional anti-doping violation under the Anti-Doping Regulations of a Member Federation or under the provisions of the World Anti-Doping Code of the World Anti-Doping Agency.
- I have not been sanctioned—even for a period of less than one (1) year—following an intentional anti-doping violation resulting from a plea agreement or settlement procedure.

C. Additional ineligibility conditions

- I am not party to pending judicial proceedings against United Rafting (International Rafting Federation and/or World Rafting Federation)
- My income does not derive, for more than fifty percent (50%), from commercial and/or entrepreneurial activities directly connected to the management of, or activities conducted under the aegis of, United Rafting (International Rafting Federation and/or World Rafting Federation)
